# **TOPICS for DISCUSSION:**

- 1. By-Laws review. Updates have been incorporated.
  - Commander reviewed integration of AG requested changes to our bylaws. The Post Executive Committee (PEC) is comprised of all elected and appointed officers plus the 3 member Executive Committee which will now be known as at-large members. This is a naming model used by other posts.
  - Several references to what the Post commander can do updated with "Post Commander requests or recommends which must then be approved by the PEC".
  - There are also some updates to officer position standard responsibilities
  - All officers asked to read the updated and provide any last minute changes. This is your last chance to update before we sign and ship off to Dept of NC.
- 2. Jacobs Reception: Preparations pretty much done. This Sat from 4pm 6pm. Setup 3pm. Several members bringing tables to layout food on. Flags were discussed and the agenda handout reviewed. Dale and Dan will review room on Friday morning. Dan to send Mike C. pictures for Jacobs dedication on website. Richard indicated we may have TV coverage. Dan has framed charter to present to family. We also agreed to give parents Post 68 ball caps.
- 3. 2020 Events and Activities What do we want to do as a Post in 2020 (see list): Dale reviewed this list with officers present. Most agreed that this is a comprehensive list of activities the Post participates in throughout the year. Jim Z brought up a couple that were missing. Many events need lead times and leaders. Commander asked that we dedicate an officers meeting to flushing out this list and firming it up for 2020. Dan needs to layout the events in a calendar.
- 4. List of veterans to receive Christmas gift cards: We do not have many names. Lane provided 4 from the Sr center with 1 a definite. Officers agreed on \$100/card with no restrictions. Lane will verify the other 3 names and have Elliott purchase the cards. This needs to be done quickly. We also determined that the caretaker of another local vet should receive a \$500 card. (see below)
- 5. Pasta Dinner follow-up: Patty Kellye attended today's officers meeting and gave an excellent after action report on the Pasta Dinner. Dan provided several certificates of appreciation for vendors who contributed to the auction which Patty will deliver & delegate Additional actions: Dale indicated getting a picture presenting certificate to the vendor

- Patty needs bag of paperwork from Dan
- Patty to get name of food vendor for a certificate

# 6. Membership actions

- a. Post 1981 transfers: Commander indicated that other Posts have done mass transfers of 1981 members into their Posts with no negative feedback from the transferred members. We plan to put together a well written letter for the transferred members explaining the transfer. Jim Z, Dan F and Richard will work this before we pull the trigger with the District membership chairman (Mike Fagen). We want this done by the end of the year.
- b. Contacting of members who have not renewed. Dan F has contacted many members. We have had 3 more renewals. Dan also found out that we have several bad email addresses. He will attend to contact those members via phone.
- 7. Election Committee for 2020: Commander discussed the upcoming elections and who is not eligible to run for their current office. Several members (elected and appointed) will be staying but several more need to be replaced.
  - a. Dale, Jim, Brian, Bill S., Lou have completed at least 2 years in their positions and are unable to run again for their current position without a PEC waiver. Requirements for waiver are in Constitution and By-laws.
  - b. Elliott has not yet been elected in his position; Mike C and John H have only completed 1 year. All 3 are eligible to run for their current position.
  - c. Appointed: Dan, Lane, John, Dan
  - d. 2 vacant positions: 2<sup>nd</sup> Vice and Historian
  - e. We need to get the election committee established so we can get candidates lined up.

#### 8. Oratorial contest and other NBHS/JROTC updates

- a. Oratorical: Post contest is Jan 11<sup>th</sup>. 3 contestants. We have more by-in from the school. Jan 4<sup>th</sup> is Post 543's contest if anyone wants to attend. District contest is Jan 18<sup>th</sup>. More judges needed for Post contest.
- b. Other NBHS/JROTC items: Dale met with Col Baker, Rick DeMoya regarding NBHS&JROTC activities. They are planning for 2 candidates from JROTC for Boy/Girls state in 2020 and 2 candidates from the general school population. We are still planning to give students a \$500 award along with \$100 each for military excellence and academics. These awards will be presented April 6<sup>th</sup> during the school awards ceremony
- c. Please note, Rick DeMoya will be stepping down as the NBHS liaison. A replacement will be needed.
- d. We are also proposing to present \$50 gift cards to students planning to attend a military academy or who will enlist in the military out of high school. This will also include a blue flag for the student's family. There was also the suggestion of including a Post 68 cap. Officers present voted unanimously to proceed with this program. We will budget for 10 12 students / year.
- 9. Flag retirement mass burning: Dan Fortini leading this effort working with John Cook. Planning to hold event on Jan 4<sup>th</sup>. Dan estimates 5 or 6 Post members will be needed. There will be a short ceremony followed by the burning.
