ELECTIONS:

Per our new Constitution & By-Laws:

- The Post Commander shall recommend a 5 member Election Committee to be approved by the PEC at an early enough date to assure adherence to the eligibility criteria contained in the C&B.
- Election Committee will consist of 4 Past or Present PEC members who are not seeking election or re-election PLUS one Post member who is not seeking election.
- The members of the Election Committee shall solicit names of potential candidates from the general membership. The committee shall compile a list of the candidates at least 7 days prior to the regular membership meeting designated as the meeting to nominate candidates for the elected PEC positions. Prior to this membership meeting the members of the Election Committee shall certify to the Post Commander the names of the nominees for each elective office for the Post. NOTE: The Membership meeting designated as the meeting to nominate candidates of the elected PEC positions is Thursday, April 16, 2020. This is the meeting where the ballot slate is frozen with the elections being held at the May meeting.
- The Election Committee has the responsibility of supervising all election procedures. See C&B for details.
