## **OLD BUSINESS:**

- Post Elections: Dan Dodge Dodge explained how Post elections process works. During our April meeting, the membership voted to freeze the ballot on our slate of elected officers. Now, during our May meeting, Post membership has the responsibility to cast their votes for those members running for office. Since there are no contested positions (IE: 1 candidate per elected position), a motion was made by Dale Todd that the Adjutant be requested to cast 1 unanimous vote for the entire slate of elected officers. Motion was seconded. Members present and online voted unanimously to elect into office, the entire slate of candidates for elected officer positions as published. There were no dissenting votes. Motion passed. Adjutant then cast a single vote in favor of entire slate of elected officers. John Hacker, incoming Commander then reported on assignments for appointed positions. All officers will be installed during our June meeting by District 9 Commander Dale Smith.

- 2. JROTC status: Dale Todd. Todd talked about presentation of Military and Scholastic Excellence medal presentations to NBHS JROTC students along with the presentation of the Post's John E Jacobs Scholarship. Post Commander Hacker along with 1<sup>st</sup> Vice Fortini met with Col Baker to present the awards. Todd also indicated that the NBHS JROTC will be dedicating their new building soon. JROTC have already received an awards board and rifle racks thru donations and work from the Post, Kiwanis and the Brunswick Forest Wood Working Club. Bench seats are currently in the works.

For Boys and Girls state, Post 68 is sponsoring 1 boy and 3 for girls state.

**Cadet Captain Andrew Powers: The John E. Jacobs Scholarship of \$500 and recognition plaque**. This scholarship is awarded on an annual basis to the NBHS JROTC Cadet who has participated full time in official JROTC functions, classes, and drills, has maintained the highest scholastic ranking, and exhibited outstanding qualities of leadership, citizenship, patriotism, and community or religious service. He was selected for the award based on a very detailed application and his essay "What it means to be a model citizen". CPT Powers is a Senior at NBHS. He has been accepted at two colleges including East Carolina University. At this time, he is awaiting news on his entrance into the ROTC program before he makes a decision.

This scholarship is named in honor of PFC John E. Jacobs, U.S. Army, killed in Quang Tri Province, South Vietnam on 1 November 1968. PFC Jacobs was the only Leland, NC resident killed in action during the Vietnam War.

Cadet First Lieutenant Solomon Smith: The John E. Jacobs American Legion Post 68 JROTC Scholastic Excellence Award of \$100 and Certificate of Excellence. The recipient of this award shall have maintained the highest ranking in Scholastic Excellence during their scholastic year and participated full-time in official functions of the JROTC including classes and drills. 1Lt Smith is a Junior at NBHS and has been accepted into the Army and Air Force Leadership Program this summer.

Cadet Command Sergeant Major Parker Lundy: The John E. Jacobs American Legion Post 68 William F. Walsh Military Excellence Award of \$100 and Certificate of Excellence. The recipient of this award shall have maintained the highest ranking in Military Excellence during their Senior year and participated full-time in official functions of the JROTC including classes and drills. CSM Lundy has enlisted in the Navy. The award for Military Excellence can continue to be worn when the cadet serves on active duty in any branch of uniformed service.

This award is named in honor of Pvt. William F. Walsh, U.S. Army, 30<sup>th</sup> Infantry Regiment, 3<sup>rd</sup> Infantry Division, Seventh U.S. Army, awarded the Distinguished Service Cross for extraordinary heroism in connection with military operations against an armed enemy while serving as a Medical Aidman in Europe on 27 March 1945.

3. NC Department Convention Delegates: Dan Dodge - Each year at the Department of NC annual convention, Posts vote on various resolutions, positions, and other business that requires attention. Posts are allocated "votes" based upon paid membership. Post 68 is allocated 5 votes based on our paid count of 197 members. Per Post bylaws, the membership must vote to allow the Commander or other authorized delegates authority to utilize those votes as the representative sees fit or based upon Post membership wishes. There are 2 resolutions to vote on this year: 1 for the size of committees and another for the creation of a finance commission. The recommendation from the Post PEC is to vote in favor of both resolutions. A motion was made by Dodge then seconded to allow the Commander to utilize all Post votes at the convention as he sees fit. Motion passed by a unanimous vote of members present and those on-line. Four Post officers will be attending the convention this year: Commander Hacker, Adjutant Dodge, 1<sup>st</sup> Vice Fortini, Service Officer Adrian.

**Service Officer Update:** Lane Adrian – Lane discussed a Dental Care program called Veteran Smiles which is a program in collaboration with the ECU School of Dentistry and the Veteran Smiles Foundation which seeks eligible veterans in NC to receive needed dental care. Vet Smiles is a program for veterans with limited financial means to receive low cost dental services. There will be an event on Sep 24<sup>th</sup>. This will include all 8 ECU schools across the State. Veterans must be vetted based upon annual income (~ \$40k/yr). About 30 veterans are expected to participate. Post members are asked to forward the names and contact info for anyone who might qualify. Program flyer to be included as attachment to minutes. See Lane for additional information.

#### MEMORANDUM FOR RECORD

SUBJECT: Nomination of eligible North Carolina Veterans for Improved Oral Health

- Approximately 8% of veterans qualify for dental services within the Veterans Administration health care system. Satisfactory oral health has a direct impact on overall status, including heart disease, a major cause of death.
- VET SMILES, an initiative based upon collaboration between East Carolina University (ECU) School of Dental Medicine (SoDM), NC Serves, and Veteran Smiles Foundation (VSF), is seeking eligible veterans within North Carolina to participate in an effort to improve their oral health.
- 3. VET SMILES is prioritizing veterans with limited financial means who do not qualify for dental care within the VA system. The veteran must grant consent to have a "means test" completed by NC Serves. If the veteran is validated within the 'low means' cohort, that information will be shared with both the ECU SoDM and VSF.
- 4. Two ECU SoDM community service learning centers (CSLC) are currently providing dental services within the VET SMILES initiative. The CSLC Brunswick County, located in Bolivia, NC, has a designated footprint that can consider veterans in the following ten counties: Brunswick, Carteret, Columbus, Craven, Duplin, New Hanover, Jones, Onslow, Pender, and Sampson.
- Once the veteran has been nominated, validated within the low means cohort, and that information has been provided to the ECU CSLC, the veteran can be scheduled for an initial exam & x-rays. The costs of those initial procedures will be paid by VSF.
- 6. The implementation of the dental care plan that results from the exam is subject to availability of funds and agreement with the veteran on cost sharing per the VSF financial support policy. In general, VSF expects the veteran to donate 50% of the cost of the dental care plan actions to help "pay it forward" to other veteran care.

The veteran should be prepared to provide: veteran's name, date of birth, and contact information including address, and phone number; as well as the care provider who recommended VSF.
